### **Highways Act 1980, Section 119: Proposed Diversion of Public Footpath No 124 – Parish of Chapel-en-le-Frith**

Derbyshire County Council has received an application for the permanent diversion of part of Public Footpath No 124 in the Parish of Chapel-en-le-Frith in the interests of the landowner to create a safe route for users of the public right of way, around a ground pipe installed by United Utilities on their land. The proposed diversion would take the path from the southern end of the path just after the stone bridge, to turn approximately westsouthwest then northnorthwest to cross the pipe then turning eastnortheast then westnorthwest to rejoin the footpath.

If the proposed diversion takes effect it will divert approximately 20 metres of that part of the Footpath shown as a bold solid line between points **A - B** on the attached plan. The proposed alternative would be approximately 40 metres long shown as a bold broken line between points **A - C - B**. The alternative route would have a crushed stone and earth surface and a recorded width of 2 metres.

The public may inspect the alternative route during the consultation period without seeking further permission.




