#### 14/280 Police Matters

PCSO Green reported on the crime statistics which were comparable with the same period in the previous year.

In 2013 there were 40 positives outcomes for crimes compared with 15 in the previous year. This equates to 25% of crimes in the year being solved.

There were no reports of anti-social behaviour over the Christmas period but there were a number of break-ins to sheds on the Courses allotments.

Members commented on the parking problems at Chinley School and it was acknowledged that this issue is a Safer Neighbourhood priority.

#### 14/282 Honorary Townsman

The Chairman sought approval from members to discuss this additional item.

The Chairman on behalf of the Council congratulated Councillor Mrs Batterbee on 25 years of service to the Parish Council.

Councillor Harrison thanked Councillor Mrs Batterbee for the service she has given to the Council as a Chartered Surveyor and as a resident. She was Chairman of the Council from 1998 – 2000 and has served as Chairman of Chapel-en-le-Frith United Charities for many years. In the past she has represented the Parish on Derbyshire County Council and the Peak National Park Authority. She is currently Chairman of the High Peak Magistrates bench.

Councillor Norton congratulated her on the achievement of 25 years' service and noted that in the last 100 years there have only been 5 members who have reached the same number of years' service. In the 23 years that he has served on the Parish Council he thanked Councillor Batterbee that she had never brought party politics into Parish Council business.

Councillor Young congratulated her and noted that she had taken over as the President of the Chapel-en-le-Frith Ladies Choir following the death of Councillor Mrs A S Young.

Councillor Harrison proposed and Councillor McCarthy seconded the following proposal:

The Chairman and Members of the Chapel-en-le-Frith Parish Council recognising the service to the Parish of Chapel-en-le-Frith by Councillor Hilary Mary Batterbee and in particular her continuous and dedicated service as a Parish Councillor for a period of twenty five years being Chairman of the Parish Council between 1998 and 200 do hereby confer upon the said Councillor Hilary Mary Batterbee the style, rank and title of Honorary Townsman of Chapel-en-le-Frith.

And it has been further resolved that the facts hereof be inscribed in a formal writing to be presented to the said Councillor in record of her service to the Parish.

## 14/283 M.P., County Councillors, Borough Councillors

Andrew Bingham MP has confirmed that the Planning Minister will be visiting High Peak on 31 January 2014 and members have been allocated a time slot to speak with him.

It was agreed that the Chairman, Chairman of the Planning Committee and Councillors Martin and Young will represent the Council at the meeting.

The Borough Councillors reported that there had been problems with waste collections over the Christmas period and that these were being addressed.

Members were concerned that Councillor Lomax has not attended many meetings and the Clerk confirmed that he did yet a copy of the agenda and minutes each month.

## 14/284 Highways, Public Footpaths and Public Services

Derbyshire County Council have forwarded a copy of the Public Diversion Order for Public Footpath 130.

Residents of Combs are experiencing problems with the high water levels currently in Combs Reservoir which is interfering with septic tanks, causing flooding and making paths around the reservoir impassable. It was agreed that the Clerk should write to the Canal and River Trust on this issue.

The Clerk was asked to enquire from the Peak National Park Authority the current legal position relating to the Royche Track.

Councillor Brook advised that a meeting has been arranged with Seddon Homes and the West Ward Councillors to discuss the parking problems on Long Lane during construction works.

# 14/331 Police Matters

There have been 12 reported crimes in January 2014 compared to 14 in January 2013, with a detection rate of 33.3% compared with 28.6%. Reports of anti-social behaviour remain at a similar level.

The Safer Neighbourhood Priority has been set to monitor parking around Chinley School.

It was noted that an amount of diesel was stolen from the building site on Long Lane, Chapel-en-le-Frith and that a quad bike has been stolen from a farm in Combs. The Police now run a farm Watch Scheme which local farmers are being encouraged to join.

# 14/333 M.P., County Councillors, Borough Councillors

Councillor Street advised that there is a meeting of the County Council on 5 February where the budget will be agreed and the extent of cuts to service known.

A proposal is to be put to the meeting asking that the County Council work closely with the Peak National Park to mitigate the effects of off roads vehicles.

Derbyshire County Council have agreed an improvement scheme for Dale Road, Dove Holes in partnership with Cemex. Cemex have announced that they will be installing a second wheel wash at the Dale Road site in Dove Holes.

High Peak Borough Council will not be taking any enforcement action on Burnside Road, Chapel-en-le-Frith until the outcome of the Planning Appeal has been determined.

The High Peak Borough Council tree expert has agreed the removal of a number of trees on the Long Lane site where planning permission has been agreed and the security fencing will remain in place until the development is completed.

Members reported on the recent meeting with the Planning Minister and Andrew Bingham MP when it was acknowledged that there have been a high number of planning approvals in the Parish. In certain circumstances the MP is able to call in applications which would be considered by the Secretary of State. Those present were advised to make representation to High Peak Borough Council regarding the delay in the preparation of the Local Plan and also to incorporate the Community Infrastructure Levy proposals on the Plan.

#### 14/334 Highways, Public Footpaths, Public Services and Parish Improvements

A complaint has been received regarding the public footpath on the Peak Forest Tramway to the rear of the Dorma site with serious flooding problems. The Peak and Northern Footpath Society have asked the Council to support their request to Derbyshire County Council that the culverts be cleaned out along the route.

Derbyshire County Council have advised the part of Eccles Road, Chapel-en-le-Frith will be closed from 17 – 21 March 2014 to facilitate verge repairs.

The Peak District National Park Authority have advised that a traffic regulation order has been made to prohibit mechanically propelled vehicles using Chapel Gate.

It was reported that the gullies on Rowton Grange Road have been cleared.

The BOAT leading from Eccles Pike is scheduled for maintenance in 2014/15.

The Clerk was asked to report blocked gullies on the mini roundabout by Morrison's petrol station and also at the entrance to Chapel High School.

The concurrent function grant being confirmed at £56,726.00 and Council Tax Support Grant of £9,047.54 making total funding available for 2014/15 of £168.694.54.

**RESOLVED:** That the 2014/15 Precept be set at £102,921 subject to receiving the Council Tax Support Grant of £9,047.54 and the Concurrent Function Grant for Parks and Open Spaces of £56,726.

## 14/344 Matters arising from the above Minutes

Punch Taverns have responded to advise that the steel shutters on the Kings Arms Public House are an insurance requirement and have instructed their security team to move the shutters to the inside of the building. The Conservation Officer has agreed to look at the Memorial Club and Kings Arms Public House to see what the best way forward is for these prominent buildings in the Conservation Area.

Risk Assessments – The current staging date for pension enrolment is advised as being between October 2015 – April 2017.

The Clerk confirmed that the date for the Honorary Townsman presentation is Friday 28<sup>th</sup> March 2014 at the Old Hall Hotel in Buxton and that the High Sheriff of Derbyshire has confirmed that he is able to present the scroll to Councillor Mrs Batterbee.

Councillor Evanson reported that he has met with British Waterways regarding water levels in Combs Reservoir.

A meeting is being held on 7 February 2014 with Federal Mogul Friction Products regarding the allotments at the Courses.

Planning Application HPK/2013/0319 – land off Hallsteads Dove Holes. The applicant has made an application for the removal of condition 18 limiting the number of dwellings to 58.

Members objected to the removal of the condition and it was felt that the current density was sufficient for the site. Members were concerned that about the lack of infrastructure in Dove Holes. The emerging Neighbourhood Plan will not allocate any further housing sites in Dove Holes as the number of houses already approved has exceeded the number allocated in the Plan.

Councillors T Norton, J Perkins and S Young declared an interest in this application as part of the site is in the ownership of High Peak Borough Council and Councillors Perkins and Young are members of the High Peak Borough Council Development Control Committee.

A quote of £4,358 plus VAT has been received from Derbyshire County Council to provide 4 parking spaces with kerbs and edgings at Eccles Pike together with steps to the stile leading to the summit.

Councillor Harrison proposed and Councillor Martin seconded that the quote be accepted as the funds had been allocated in the Regeneration budget. All members were in agreement and thanked the Ward Members for taking the project forward.

A meeting is taking place on 6 February in Whitehough with residents to look at a proposal to refurbish the area around the well in the centre of the hamlet.

A meeting of the Communications Committee was arranged for Thursday 13 February to compile the newsletter. It was agreed that the procedure for the issuing of press releases be considered.

A meeting of the Working Group to consider the new Standing Orders has been arranged for 7 February 2014.

## 14/345 Neighbourhood Plan

The Neighbourhood Plan Working Group are meeting on 5 February to assess the comments made during the consultation period. A meeting has been arranged with the Councils advisor to seek assistance with specific comments. Members agreed that it may be necessary to employ a planning consultant to represent the Council at the inspection stage.

It was noted that once the Examination Version of the Plan has been prepared it will be handed over to High Peak Borough Council to take it forward to inspection. Should the Plan eventually be adopted High Peak Borough Council will receive £25,000 from Central Government.

It was acknowledged that the designation of Green Spaces is open to interpretation.

A comprehensive list of comments has been received from Chapel Vision and there had been a suggestion that they could be invited to part of the meeting on 5 February. However, members agreed that if any one consultee be given preferential treatment it could lead to a challenge when the Plan is inspected.

## 14/346 WW1 Centenary Commemorations

It was agreed that any improvements that could be made to the Memorial Park with grant assistance could be a project to commemorate the centenary of WW1. It was suggested that the names of those who fell in WW2 could be commemorated in a book.

It was suggested that a display in the Library or Annexe could be arranged of photographs or artefacts.

There has been a suggestion that names of roads on the Barratt development at Federal Mogul could include names of those involved in the Dambusters raid and other service. Some members were not in agreement to surnames being used to name streets. The Council have not get been consulted on the proposal.

The Friends of Chapel Station are to create a poppy border at Chapel South Station.

Sgt Maddock attended the meeting to introduce himself to members having been appointed to the Safer Neighbourhood Team following the retirement of Sgt Barlow.

The Peak Park Parishes Forum have produced a list of issues for Parish Councils to address in relation to the Peak District Cycle Strategy. Members were encouraged to submit their views on the current consultation.

The Clerk was asked to query the signage and road markings on Horderns Road, Chapel-en-le-Frith by the Catholic Church as the information appears to be conflicting.

The responses are currently being reviewed and due to the complexity of some of those from planning consultants it was agreed that 3 days professional support be paid for from the Vanguard Grant.

Members were also advised that a judicial review is currently taking place on the Tattenhall Neighbourhood Plan and the outcome of this may have implications on the Chapel Neighbourhood Plan. The judgement is expected at the end of March 2014.

#### 14/400 Police Matters

Pc Crosthwaite advised member's that there have been 12 reported crimes in March 2014 compared to 11 for the same period in 2013, with a positive outcome of 41.7% compared to 58.3% in 2013.

There have been 11 reports of anti-social behaviour in March 2014 compared with 16 for the same period in 2013.

The Police were asked to monitor cars parking on Longson Road, Chapel-en-le-Frith at School times, blocking the pavement and driveways together with vehicles parking on yellow lines on Buxton Road, Chapel en-le-Frith obscuring site lines from Sheffield Road.

The Police confirmed that they have spoken to Barratts to ask that building supplies are delivered to the Federal Mogul site off the by-pass and not along Hayfield Road, Chapel-en-le-Frith.

The cycle event at Chapel Leisure Centre will take place on 19<sup>th</sup> May 2014 and the Police will liaise with the organisers due to the problems encountered last year.

## 14/401 Open Forum

Peter Soden has been co-ordinating the comments on Local Green Spaces for the Neighbourhood Plan and updated members on the current position and highlighted areas where further comments were required.

## 14/402 M.P., County Councillors, Borough Councillors

Councillor Street reported that the County Council have agreed to support the protection and preservation of Green Lanes. It was noted that in Derbyshire

Dales there is signage to indicated 'Quiet Lanes' and Councillor Street said that she would be happy to put forward specific roads where signage might be appropriate. Councillor Martin agreed to bring the matter to the attention of the Green Lanes Forum.

The results of the consultation on the Mobile Library Service are awaited. The County Council have made extra funding available for the restoration of pot holes.

The planning application lodged by Jalo Enterprise is now subject to an appeal.

#### 14/403 Highways, Public Footpaths, Public Services and Parish Improvements

The Peak and Northern Footpath Society have reported that they have contacted the Rights of Way Officer at Derbyshire County Council for an update on the Chapel F/P 124 (Dorma) regarding the Definite Line of the footpath. The Derbyshire County Council mapping team have advised that "Harris" fencing has been erected to the west side of the Definite Line and needs to be moved back and away from the stream, this means that the footpath if agreement with the contractors is made will be on higher ground and therefore dryer.

With regards Chapel F/P 172 (Tramway in Whitehough) it most important that this water problem is resolved permanently as to stop the flooding on Whitehough Head Road as now the water table is dropping the problem will go away until next winter. The root cause of this the blocked drain at / near Blackbrook River which is believed to have been caused by the new water main to Dorma that was put in late 1990.

Members have been circulated with details of proposals being put forward by Stockport Metropolitan Council in relation to the A6 corridor, Hazel Grove. Members were asked to submit comments to the Clerk by 10<sup>th</sup> April 2014.

Councillor Brook as Chairman of the Friends of Chapel Station advised members that it was likely that some work would be taking place to install a footbridge but at this stage no firm details were known.

At the commencement of the meeting there were twenty eight members of the public and no members of the press present.

Rev D Leach said prayers.

#### 15/45 Declarations of Interest

None

The Chairman sought approval to alter the order of business to make the Open Forum the first item of business.

#### 15/46 Open Forum

Mrs Laister addressed the meeting on behalf of the Parish Church regarding the following:

- The recording of the names of all those who served in WW2 in a public place.
- During the Patronal Festival in July the Parish Church are intending to have an exhibition to commemorate the WW1 centenary.
- Would the Council like the Parish Church to organise a Civic Service to commemorate the WW1 centenary.

The Chairman of the Amenities Committee advised that they were looking at ways of recording names of those who served in WW2 following Mrs Laister's suggestion at the Annual Parish Meeting.

The Communications Committee are looking to organise an exhibition in the autumn and it was agreed that information may be able to be shared. The Council agreed to consider the proposal for a Civic Service.

Mr Dodd spoke on behalf of residents of Long Lane, Chapel-en-le-Frith regarding the recent advertisement in the Buxton Advertiser advising that the road would be closed for a period of 6 months.

Residents have the following concerns:

- The lack of communication from the Developer with residents about the road closure
- What guarantees are in place for access to properties, businesses and the railway station during the proposed closure?

- What are the proposals for emergency access?
- What length of the road will be closed at any one time?
- The proposal to route surface water into the watercourse could cause flooding problems downstream

The Chairman asked the County Councillor to outline the position of the County Council on this matter and Councillor Young to outline the position of the Borough Council.

Councillor Mrs Street reported that she had sympathy for the residents would will be affected by the proposed work.

Derbyshire County Council received an application from Utilities Design and Planning Ltd on behalf of the developer Seddon Homes to undertake work in the highway and as a consequence to close the road whilst the work is being undertaken.

The County Council has a responsibility to ensure that any contractor working in the highway has the necessary street works accreditation and public liability insurance. In this case the application made on behalf of Seddon Homes complies with the Street Works Act.

The County Council have an obligation to facilitate the works and have to advertise road closure but do not have a duty to consult with individual residents. High Peak Borough Council gave planning permission for the development and as part of that permission the proposed work should be been agreed prior to the commencement of the development.

The County Council do not feel that 6 months is an unreasonable time to undertake the work and due to cost implications it is in the developer's interest to complete the work as quickly as possible.

The work will be completed in stages and access to properties maintained at all times together with access for emergency vehicles.

Should the work continue into the winter months then the County Council will ensure that the road from Long Lane to Martinside is adequately gritted, All signage will be the responsibility of the contractors but will be checked by the

County Council on a regular basis.

If residents are financially inconvenienced by the work they should contact the developer in respect of compensation.

Councillor Street said that she felt that Seddon Homes should have written to affected residents to advise of their plans and cover issues such as noise, dust and working hours.

Councillor Young reported that he had spoken to the Borough Council who initially advised that their responsibility only extended to works within the red line drawn on the planning application. However, in the consent issues by the Borough Council in respect of the planning permission conditions 12 and 16 which relate to surface water and functional services appear to not have been discharged properly. The Head of Planning at High peak Borough Council has left the Authority and as urgent meeting is being sought with the person in temporary charge.

Members of the Parish Council commented that they had received no prior indication of the proposal for the works and associated road closure before 20<sup>th</sup> May. Members who represent the West Ward advised that they sought a meeting with Seddon Homes at the commencement of the work to encourage a working dialogue and were disappointed that they were not consulted about the proposed

works. Seddon Homes have now indicated that they intend to leaflet all affected properties next week.

Members will fully support residents to ensure a satisfactory solution to the issue but emphasised that the Parish Council have no powers and in the case of planning matters are only a consultee and make comments alongside other consultees and residents.

Residents advised that they were looking to appoint Solicitors.

Mr Sizeland addressed the meeting and introduced himself as the Managing Director of CJK Packing who operate from the site a Bridgeholme Mill which is in his ownership. The Company export worldwide and he estimates that they plough 250k per year into the local economy.

Councillor Perkins and Young declared an interest as members of the High Peak Borough Council Development Control Committee and left the meeting as planning issues may be discussed.

Mr Sizeland advised that the Company were looking to expand on a modest level and rather than re-locate were looking to use a piece of land on the site which is currently designated as Green Belt. His understanding is that this designation dates from the time of the construction of the A6 by-pass. The area he would like to develop has previously been used as an infill tip. He advised that during meetings with Chapel Vision he was led to believe that the Green Belt designation on this land would be amended in the Neighbourhood Plan which has not been the case.

Mr Sizeland was advised that the Neighbourhood Plan has now been passed to High Peak Borough Council and that the Parish Council considered his representation to remove the land from the Green Belt and took professional advice on the matter. The decision was made that to ensure that the Plan conformed to both local and national policies and no re-designation of Green Belt land would be made in the Plan. Mr Sizeland was advised that should he disagree then the way forward would be to submit a planning application for the site.

High Peak Borough Council will be required to run a further 6 week consultation on the Neighbourhood Plan and this will give an opportunity to make further comment.

Councillors Perkins and Young re-joined the meeting.

## 15/47 Police Matters

The Police have submitted apologies for the meeting but have provided crime statistics. There are 17 recorded crimes for April 2014 compared with 22 for the same period in 2013. This gives a 22.7% reduction in crime for the month and a positive outcome rate of 23.5%.

There were 18 reported incidents of anti-social behaviour and the Police report that this is down to an ongoing problem with one person in the Memorial Park. Members were concern that detection rates were low and it was agreed that the Safer Neighbourhood Sergeant be invited to speak with the Council on this issue and also about any new initiatives that may be put in place. Members also commented that it would be useful to have some feedback on restorative justice.

# 15/48 M.P., County Councillors, Borough Councillors

Councillor Mrs Street advised that she has been appointed as the shadow cabinet member for Children and Young Adults at Derbyshire County Council.

Councillor Young reported that there will be a change in the management structure at High Peak Borough Council and that he and Councillor Perkins are meeting with the temporary Planning Manager to discuss the Long Lane development.

#### 15/49 Highways, Public Footpaths, Public Services and Parish Improvements

Derbyshire County Council have advised the following road closures:

A6 at Barmoor Clough from 14 July to 25 July each weekday night between 19.00 hours and 22.00 hours to facilitate embankment stabilisation works. Councillor Brook reported that the County Council have advised that when Barmoor Clough is closed Long Lane will be open as an alternative route.

Winnats Pass from 30 June to 18 July for a 5 day period during the dates specified to facilitate carriageway resurfacing works.

Un-named road at Slackhall between 23 June and 5 July to facilitate bridge repair works.

Long Lane, Chapel-en-le-Frith between 16 June and 15 December for sewer installation works.

Derbyshire County Council have provided an update following the meeting held on Church Brow regarding the demarcation of the carriageway with brass studs. The department of Transport have imposed a moratorium on any new authorisations over the last year pending a new set of Traffic Regulations to the published in March 2015.

When the Traffic Officer has visited the site there have been no problems regarding parking and he has asked the Parish Council if they would be able to provide some information about issues that arise in the evenings or at weekends. It was agreed that residents be asked to keep a log of any problems.

A resident of Whitehough has asked that a tripping hazard on the footpath between Meadowbank and the Tramway be reported.

The Borough Councillors were asked to pass back comments about weed spraying which needs to be undertaken before any weeds have a chance to seed.

Complaints have been received about the standard of grass cutting.

There are still problems on the steps by the Nat West Bank in Chapel-en-le-Frith during heavy rainfall as the gulley on the Market Place is not connected to the drainage system.

Residents of Horderns Road and Rowton Grange Road, Chapel-en-le-Frith have passed on positive comments about the recent surface treatment of footpaths.

The Clerk was asked to seek confirmation from Derbyshire County Council regarding the review of the parking restrictions in the lay-by on Hayfield Road East.

Overall Chapel-en-le-frith and Hope Valley are very good apart from the number of long term unemployed people where they are the highest in Derbyshire. She will let members have a copy of the data. Councillor Evanson concurred with this as the NOMIS database indicates a similar trend.

Local Authority Governors are now to be appointed by Local Area Committees after an endorsement by the local member. Councillor Street indicated that she is seeking further information regarding background checks as she may be asked to endorse people who she does not personally know.

The County Council are to remove the diversion sign for Long Lane which is situated on the Morrison's roundabout as this is misleading to motorists.

At present the situation regarding the proposed road closure at Long Lane is confusing as a statement issued by Seddon Homes does not correspond with the Traffic Order for the road closure. The MP has been asked to pursue the matter and seek clarification following assurances he received from the developers.

Derbyshire County Councils Traffic Officer has confirmed that a meeting took place with the Police following the fatal accident on the A6 by-pass and some additional signage on the carriageway is proposed.

It was agreed to adopt the following protocol:

Meetings or parts of meetings from which the press and public are excluded may not be filmed or recorded.

Members of the public are permitted to film or record meetings to which they are permitted access in a non-disruptive manner.

The use of digital and social media recording tools, for example Twitter, blogging or audio recording be allowed as long as it is carried out in a non-disruptive way and only to the extent that it does not interfere with any person's ability, even where he or she has a disability, to follow the debate.

Whilst those attending meetings are deemed to have consented to the filming, recording or broadcasting of meetings, those exercising the rights to film, record and broadcast must respect the rights of other people attending under the Data Protection Act 1998.

The Chairman of the meeting has the authority to stop a meeting and take appropriate action if any person contravenes these principles or is deemed to be recording in a disruptive manner.

Any person or organisation choosing to film, record or broadcast any meeting of the Council or a committee is responsible for any claims or other liability from them so doing. The Council asks those recording proceedings not to edit the film or recording in a way that could lead to misinterpretation of the proceedings, or infringe the core values of the Council. This includes refraining from editing an image or views expressed in a way that may ridicule, or show lack of respect towards those being filmed or recorded.

The Council will display requirements as to filming, recording and broadcasting at its meeting venues and those undertaking these activities will be deemed to have accepted them whether they have read them or not.

The Council may itself photograph, film, record or broadcast meetings and can retain, use or dispose of such material in accordance with its retention and disposal policies.

Any person wishing to film or record a meeting must make application in writing to the Clerk of the Council 3 clear working days before the date of the meeting with full details of name and address.

## 15/127 Police Matters

Sgt Maddock reported that the crime figures for July showed no great changes from the same period in 2013 and a reduction in anti-social behaviour incidents.

There have been a number of burglaries and the Police have mounted increased patrols in the hours of darkness and undertaken stop checks on vehicles. The Safer Neighbourhood Team Officers have been offering crime prevention advice to local residents. An arrest has been made in connection with an attempted burglary on Warmbrook Road, Chapel-en-le-Frith.

Sgt Maddock confirmed that the Police Traffic section are looking at the report regarding poor sight lines due to overhanging vegetation at the Morrison's Roundabout which was brought to their attention at the recent Safer Neighbourhood meeting.

Detection rates have fallen in the last twelve months but there is no evidence that this is due to staff changes. Rural crimes are historically difficult to solve as there are rarely eye witness accounts or CCTV.

Members received a copy of the minutes taken at the multi-agency meeting in the Memorial Park relating to issues with the MUGA. A letter has also been received from the MP in this respect following a complaint made to him. It was noted that there was an omission from the minutes as the Environmental Health Officers had reported at the meeting that they had taken noise readings over a period of one week and there were no significant issues to report. This was during the World Cup and they agreed to take further readings at a time when there were more users on the MUGA.

The Clerk advised that the Park staff have carried out some welding work on loose panels and have sound proofed the wickets. Members asked the Clerk to

pass on their thanks to staff who have acted quickly to try and resolve the problem.

## Councillor Norton arrived at 7.50pm

The MP has suggested that consideration be given to installing mosquito equipment but both the Police and Environmental Health Officers did not feel that this was an appropriate location for this type of equipment.

It was agreed that the Amenities Committee meet to consider the following requests:

- Improved signage stating hours that the MUGA can be used
- Planting of hedging and trees
- Removal of seats from the area
- Netting to stop balls been hit outside the MUGA area.

Sgt Maddock advised that he was making enquiries to see if money from the proceeds of crime could offer a grant towards some of the proposed work.

The Chairman and Clerk have met with the Consultant commissioned by High Peak Borough Council to undertake the 'health check' on the Neighbourhood Plan.

It was noted that the Peak District National Park Authority are presenting the Neighbourhood Plan to their Development Control Committee on 8 August 2014 with a recommendation for approval by Officers.

Members were concerned that the Neighbourhood Plan has been with High Peak Borough Council for 9 weeks and has made no progress.

Planning Application HPK/2014/0418 was determined by the High Peak Borough Council Development Control Committee on 4 August 2014 with approval given. Members were very concerned that the Officers report did not advise members of the status of the Neighbourhood Plan now that it has reached the Examination Version and in the opinion of members underestimated the weight that it should be given.

In addition some of the Committee members were minded to ask for a deferral to investigate the issues further but were advised that if a decision was not reached by 7 August 2014 permission would be granted by default.

Councillor Norton advised that he had spoken with the MP and has a meeting arranged to ask the MP to call the application in to the Secretary of State.

Councillor Brook tabled a motion in respect of the process High Peak Borough Council had followed in relation to the planning application. Members felt that a more effective way to tackle the issue was to write to the Chief Executive at High Peak Borough Council outlining the Councils complaint. It was agreed that this way forward should be pursued and that copies be sent to the Cabinet Member for Regeneration at High Peak Borough Council, the Strategic Director for Regeneration and Andrew Bingham MP.

Councillor Young did not take part in the discussion as he is a member of High Peak Borough Council Development Control Committee but confirmed that he was in agreement with the course of action proposed. As the Planning Application has been determined he felt that there was no conflict of interest.

A meeting has taken place with residents on Quentin Road to discuss putting a waiting limit on the yellow lines. It was noted that the yellow lining work on Long Lane has not yet been completed.

The MP has raised the issue about the weight that should be given to Neighbourhood Plans in Parliament and has supplied a copy of the Hansard entry.

It was reported at the recent Liaison meeting that High Peak Borough Council hold with Town and Parish Councils that there will be no proposed changes to the concurrent function grant or the Council Tax Support Grant in 2015/16. However, this may not be the case for successive years.

The Peak District National Park Authority are in the process of appointing a new Chief Executive and an announcement is expected shortly.

## 15/277 Highways, Public Footpaths, Public Services and Parish Improvements

Derbyshire County Council are proposing to make changes to the Road Traffic Order on Quentin Road and are running a statutory consultation on the proposed changes until 19 December 2014. It was reported that a meeting has been held with residents to outline the proposed changes.

Derbyshire County Council have advised that the B6061 will be closed at Sparrowpit until 15 December 2014 due to a collapsed mineshaft. The Clerk was asked to contact Derbyshire County Council to ask that better diversion signage is put in place.

Derbyshire County Council have advised that the Byway Open to All Traffic No 144 at Rushup Edge will be closed from 15 December 2014 to 31 March 2015 to facilitate public safety during maintenance work.

Derbyshire County Council have confirmed that they have contacted all homeowners on public footpath 61 to ask them to cut back overhanging vegetation. The Clerk was asked to check that this includes the section of path leading from Manchester Road.

The Clerk was asked to contact Derbyshire County Council following a complaint made from a member of the public that the footpath on Sheffield Road, Chapel-en-le-Frith leading to the Chestnut Centre is overgrown and difficult to navigate in places.

The Clerk was asked to report fly tipping in the lay-by at the top of Peaslows and also in the lay-by just after the Wanted Inn on the A623.

Residents of Hayfield Road, Chapel-en-le-Frith are still encountering problems with emissions from a wood burning stove located behind Chapel Garage and the Clerk was asked to contact the Environmental Health Department at High Peak Borough Council.

Residents have complained that Hayfield Road, Chapel-en-le-Frith is not being kept swept by Barratt Developments and the County Council will be asked to monitor the situation.
