At the commencement of the meeting there were five members of the public and no members of the press present.

Councillor Harrison said prayers.

20/207 Declarations of Interest

The following declarations of interest were made:

Councillor J Adshead – Chapel Town and Junior Football Club.

Councillor C Sizeland – Leys Allotment site as an adjoining land owner

Councillor C Sizeland – his wife is a substitute Councillor on the High Peak Borough Council Development Control Committee

Councillor S Walters — Chapel Market Place and the Leys Allotments as friend of Councillor and Mrs Sizeland

Councillor Gourlay declared the following interest:

'I declare an interest in the tender process for the sale of the Leys land, as I have a friend who will probably bid if that sale takes place. However, I intend to talk later about the process by which allotment status was removed from the Leys allotments, and I feel I can discuss this with impartiality'.

20/208 Co-option Chapel East Ward

Two residents applied for co-option for the vacant seat in Chapel East Ward. Mrs Patricia Green and Mr James Lambert.

A vote was taken with Mrs Green receiving 5 votes in favour and 4 votes against. Mr Lambert receiving 4 votes in favour and 5 votes against.

RESOLVED: That Mrs Patricia Green be co-opted onto the Council for Chapel East Ward.

20/209 Police Matters

Once the crime figures have been updated on the Derbyshire Constabulary website they will be presented to members.

20/210 Open Forum

A resident spoke about the Leys Allotment site and advised the Council that it was his opinion that he had been wrongfully evicted as an allotment holder in 2017.

20/211 MP, County Councillors and Borough Councillors

Councillor Perkins was not able to be present at the meeting due to holidays but asked that if members had any issues to email him directly.

It was confirmed that the change in the Library opening hours in Chapel-en-le-Frith was following a consultation by Derbyshire County Council on the Library service in Derbyshire.

The Borough Councillors were asked to update residents of Rosebay Gardens in Chapel-en-le-Frith about the status of the open space as agreed in the planning permission.

High Peak Borough Council are repainting some road signs.

Councillor Mrs Sizeland sent a report that she is working with the County Council with regard to highways matters on Long Lane, Chapel-en-le-Frith, in respect of the Rosebay Gardens development.

There are no further developments to report regarding the re-instatement of the CCTV camera on the Kings Arms Hotel.

20/212 Matters relating to Highways, Public Footpaths, and Public Services and Parish Improvements

The Clerk was asked to contact High Peak Borough Council regarding the public open space and play area on South Head Drive, Chapel-en-le-Frith to seek a resolution to the current issues.

It was noted that the S106 legal agreement is between High Peak Borough Council and Barratt homes and the Parish Council should not be looking to take on a liability that others have responsibility for.

Telephone Box adoption in Bagshaw

A request has been made by a resident of Bagshaw that the Council adopt the red telephone box in Bagshaw. The Clerk was asked to contact the resident regarding the future maintenance as other boxes adopted in the Parish are maintained by local groups.

Traffic arrangements Hayfield Road

There will be no further public consultation on Hayfield Road, Chapel-en-le-Frith and it two way traffic will be re-instated.

The following other matters were reported:

- There has been flooding in Whitehough again during recent heavy rain, which should be addressed by a new culvert.
- The lights on the War Memorial in Chapel-en-le-Frith are not working.
- Water is running down the steps from the Market Place onto Market Street as the grid does not take the water away.
- High Peak Borough Council are looking to bring their CCTV operation back in house.

20/224 Allotment Sites

Proposal to reopen the Leys Allotment site to supply allotments

The Chairman outlined the points to consider in relation to the Leys Allotment Site:

- The site is situated in an area designated for employment use in the High Peak Local Plan and Chapel-en-le-Frith Neighbourhood Plan. The Council has a duty to uphold the Neighbourhood Plan which was adopted following a public referendum.
- The Council has worked in partnership with High Peak Borough Council to bring the land forward for employment use and a financial contribution has been made towards employing Consultants.
- High Peak Borough Council have identified that there is a need for employment sites in the Parish.
- The allotment statutory status has been lifted on part of the site which is subject to providing new allotments on the remainder of the site.

It was suggested by some members that the Council had not approved the application made to the Secretary of State. It was confirmed that the Council did approve the application and the minute of the decision accompanied the application which was requested by the Secretary of State. This minute was agreed in confidential business as interested parties and land values were discussed. Now the Secretary of State has made a ruling this is in the public domain.

Councillor Gourlay proposed and Councillor Adshead seconded a motion that the Leys allotment site be re-opened to supply allotments.

Four members voted in favour and 5 against.

RESOLVED: That the Leys allotment site is not re-opened.

Keeping of livestock on allotments

The Chairman advised that the keeping of livestock was not permitted on the Courses Allotment site or the Dove Holes Allotment site.
